




We create excellence at all levels

We exceed the global minimum standard

We expect our suppliers to adhere to these principles and demonstrate a sound understanding of our GELITA values.


Our minimum requirements are summarized in our **Supplier Code of Conduct**.



We exemplify integrated quality

We not only demand a consistently high quality of products and services from our suppliers, we also expect outstanding quality in terms of the collaborative partnership.

For us, consistent high quality means above all guaranteed compliance with the specified product properties of services, as well as adherence to the agreed delivery quantities and deadlines. These requirements are mandatory prerequisites for a long-term supply relationship and are included in our regular supplier evaluations. Due to the transnational nature of our purchasing organization, we apply these requirements globally.





We exemplify integrated quality

We have an integrated management system with certifications in accordance with ISO 9001, ISO 14001, ISO 50001, FSSC 22000 and in some cases GMP+. We expect our suppliers to have a comparable quality management system and to actively use this in the context of their own suppliers. This enables them to guarantee their adherence both to the legal requirements and the parameters agreed with us. For product-critical materials or materials that come into contact with our products, the complete traceability of the constituent products must be ensured.

In order to guarantee the required quality, we perform regular audits of our suppliers, in which potential improvements are identified and realized. A willingness to undergo audits and to play a role in their design is thus a prerequisite for a delivery relationship with us.

In addition, we conclude quality assurance agreements with strategic suppliers. We are continually developing these in order to continuously improve the entire supply chain with regard to product and service quality.




We operate a professional supplier management

Our suppliers are important partners and an integral part of our company's success.

Through our professional supplier management system, we ensure that we only work with the best and most efficient suppliers.

Supplier management at GELITA consists of four components:

Supplier pre-selection
 Supplier assessment
 Supplier rating
 Supplier development





We operate a professional supplier management

1 Supplier pre-selection:

Suppliers register via a link on our website and can then be given the status "Potential supplier". From the pool of potential suppliers, we select suitable candidates to undergo our approval process.

2 Supplier assessment:

Suppliers who successfully negotiate our systematic and transparent approval process are given "Approved" status. Orders are only assigned to approved suppliers.

3 Supplier rating:

We regularly evaluate the performance of our active suppliers according to 12 demanding, but fair, criteria (quality, costs, cooperation, innovation and sustainability).



The supplier evaluation is concluded with the awarding of the status "Preferred", "Advanced", "Accepted".

4 Supplier development:

The goal is to systematically and continuously further develop the supplier via jointly coordinated measures.



We rely on electronic purchasing



We want to make our purchasing processes more efficient with the help of electronic purchasing solutions. Since we can only achieve this by working together with our suppliers, their support is essential.

We currently use a range of electronic tools and processes, including electronic catalogs, electronic order transmission and electronic invoicing. We want to expand these internally and externally with our suppliers.

Catalog procurement

To ensure efficient catalog procurement, we integrate web catalogs into our ERP system using the OCI interface (Open Catalog Interface). The communication process is defined in the OCI standard. This must be supported by the supplier. We transfer the shopping cart into our purchasing software and generate an order that runs via our standard workflow. We then transfer the order electronically to the supplier's web shop portal.



We rely on electronic purchasing

Electronic order transfer

A prerequisite for electronic order or invoice transfers is the conclusion of an EDI agreement. The formats supported by us for electronic order transfers are listed in the agreement, which we will provide as a download on our homepage.

Electronic invoicing

The following options are available for invoicing:

⇒ Electronic invoicing via EDI

Our standards for this are set out in our EDI agreement.
